



CALIFORNIA EVAPORATIVE EMISSION CONTROL WARRANTY STATEMENT YOUR WARRANTY RIGHTS AND OBLIGATIONS

The California Air Resources Board, U.S. EPA, and Genie, a Terex Company are pleased to explain the evaporative emission control system's warranty on your 2022 RT69 & Z34 models. In California, new equipment that use small off-road engines must be designed, built, and equipped to meet the State's stringent anti-smog standards. Genie warrants the evaporative emission control system on your RT69 & Z34 models for the period listed below provided there has been no abuse, neglect, improper maintenance or unapproved modifications of your equipment leading to the failure of the evaporative emission control system.

Your evaporative emission control system may include parts such as: carburetors, fuel tanks, fuel lines (for liquid fuel and fuel vapors), fuel caps, valves, canisters, filters, clamps, connectors, and other associated components.

MANUFACTURER'S WARRANTY COVERAGE:

This evaporative emission control system is warranted for two years. If any evaporative emission-related part on your equipment is defective, the part will be repaired or replaced by Genie, subject to the terms herein.

OWNER'S WARRANTY RESPONSIBILITIES:

1. As owner of an RT69 or Z34, you are responsible for having the required maintenance specified in your owner's manual performed. Genie recommends that you retain all receipts for maintenance of your RT69 or Z34 model but Genie will not deny warranty coverage solely due to missing receipts.
2. Genie may deny you warranty coverage if your RT69 or Z34 or a part has failed due to abuse, neglect, improper maintenance or unapproved modifications. Please consult the Genie Limited Product Warranty for specific terms and conditions.
3. You are responsible for taking your RT69 or Z34 to a Genie dealer for repair as soon as the problem is discovered. The warranty repairs shall be completed in a reasonable amount of time, not to exceed 30 days.
