Owyen continues: “The goal of hosting this webinar during OSHA's National Safety Stand-Down week is to continue to raise awareness about operating MEWPs safely at height. This week gives us the opportunity to highlight the upcoming changes to the ANSI and CSA standards, further increasing our customers' awareness about the proper use of MEWPs and associated responsibilities.”
